committee was present. Joyce Kirkwood raised her hand and
then explained that it was taken care of and that now it was in
the hands of the Board and they will take the decision regarding
that case.

during the last few weeks to prepare the grounds to receive the
new mulch. All the weeds had to be removed. He also talked
about taking ownership of our buildings, to look around and pick
