LET THE GOOD TIMES ROLL

The annual migration of "SNOWBIRDS" is underway and as they land at their winter homes at LCG the plans for entertainment and fun arrives with them. Last year was a banner year coming off Covid and this year looks to be even "bigger and better". The Activities Office opened on October 17th staffed by volunteers. More volunteers are needed. Anyone willing to assist in the Activities Office is asked to contact Howie Allen. The office will be open on Mondays, Wednesdays, and Fridays from 9:30 AM to 11:30 AM. Keep an eye on the bulletin boards for the monthly activities calendar and for flyers announcing special events that will be taking place.

COVID 19 is still a concern for our elderly community, however, things are gradually getting back to normal. Please note that participation in any of the scheduled events is voluntary and "at your own risk". Anyone who does not feel comfortable attending any of the scheduled events should not sign up to participate.

It was apparent from last year's musical events that many preferred the outdoor events on the East Pool deck. We have planned more of these events for this year along with others in the auditorium. As always, the outdoor events are contingent on weather and will be moved indoors if the need arises. At the end of last season a number of new folding round tables were purchased from the activities account. These new portable lightweight tables are larger and make set-up much easier. They are also preferred over the rectangular tables as attendees find socializing with friends much easier. Another enhancement from last year is new stage lighting in the auditorium. The new stage lighting was purchased from the activities account as well.

As you will see on the monthly calendars, regularly scheduled events include: Wednesday Bingo, Sunday movies, Karaoke, Monday Bus to the Beach, Lunch trips, Casino trips, Shopping Mall and flea market trips and Brewery trips. A minimum of 6 persons must be signed up in advance for use of the bus or the event will be canceled. After hours and weekend bus trips require a minimum of 15 persons and a \$10 non-refundable sign-up charge to help off-set the driver's overtime. The maximum number of seats available on the bus is 24 and will be on a "first come first served basis" based on sign up in the activities office.

We are planning some unique ideas for this year's events. One or more of the outdoor events will be an "ice cream social". We are also planning for an "iced coffee bar" to be included in some of our indoor events. The meals at the indoor events will include some of the fan favorites; Thanksgiving Turkey and dressing, ham and scalloped potatoes, chicken parmesan and pasta, smothered pork chops over rice, and St. Patrick's Day traditional corned beef and cabbage.

Property Manager's Report

I think we can officially say the Season has begun! It is so nice to see all the faces returning to LCG! Much has changed over the summer.

As you know we now have a CPA firm in place of an in-house controller. Carr, Riggs, and Ingram are now managing the Association's financials. This will provide the Association with consistent financial tracking and processing. For you, there won't appear to be much of a change. You are still very much encouraged to come into the office for assistance with your accounts. **For faster and more efficient payment processing, please utilize the payment lockbox address: Lake Clarke Garden c/o Synovus PO Box 1030 Lehigh Acres, FL 33970, or set your payments up via ACH.**

Sonny, our new maintenance supervisor, has adjusted very well to LCG. Maintenance and Management are working to create a more efficient and diligent work order system. We are developing preventative maintenance programs for components of the property. Maintenance schedules and workloads have been adjusted to better suit the needs of the property.

The Emergency phone number (561-308-2416) is to be used Monday - Friday from 4:00 PM - 8:00 AM, and Saturday & Sunday. During regular business hours contact the Office. If it is after 3:00 PM, and before 4:00 PM, please leave a message. The phones are monitored, and your call will be returned immediately for EMERGENCY purposes only.

If you haven't filled out your 2022 census and you are heading to LCG, or you are already here, be sure to do so. The census ensures we have all your information updated in our systems. This includes Park-In-Spot to avoid your vehicle getting booted. **Be sure to include all the information required, especially your license plate number.**

Over the summer the management office implemented a new unit key filing system. During this process, it became apparent that many unit owners do not have an emergency key on file with the Association. **Per the rules and regulations, an emergency key must be kept on-site with the management office for emergency purposes.** These keys are kept in a locked key box and signed out only for emergency purposes or with the unit owner's permission. Please be sure to update the management office with an emergency key if you haven't already done so.

As the holidays approach and you begin to entertain and cook holiday meals, it's important to remember what not to put down the kitchen sink and even your toilets. With holidays such as Thanksgiving comes a lot of food. However, while you're prepping your food, you may not be aware of what you're disposing down the drain and what harm it may do. Certain items should absolutely NOT be put down your drain if you want to avoid a catastrophic plumbing disaster and possibly a large bill. Some of these items include, but are certainly not

limited to, turkey bones (or any bones, really), potato peelings, carrot peels, eggshells, gravy or grease, celery, cooking oils or fats, coffee grounds, and anything of large quantities. Reminder for Emotional Support Animal Owners



Since the Holidays are approaching and we begin visiting and traveling, remember your ESA/service animals are approved, with documentation, for a particular resident. If you decide to leave, for even a short period of time, the animal is not approved to stay with another individual. The animal must also travel with you. Please see the documentation from the Pet Policy below:

"Approval of an emotional support animal and/or service animal is limited to the requesting party and his/her needs. If the requesting party no longer resides in this community, is no longer visiting, or temporarily vacates the property, for whatever reason, the emotional support/service animal is not permitted to remain. The approval of an emotional support/service animal does not apply to a residence generally, but rather, is only approved for a particular person. If that person is not in residence, the animal may not be in residence."

Surfside Inspection Law

Last May, Governor DeSantis signed a new condo building safety law after the tragic Surfside building collapse in June of last year. The new law affects us all.

The law requires a milestone inspection to be completed by a state-licensed architect or engineer by December 31, 2024 - a mandatory structural inspection of all our buildings three stories or higher. This is an inspection to determine if our buildings are structurally safe. He/She must determine any necessary maintenance, repair, or replacement of any structural component of the building. **The inspection has two phases:**



In **Phase 1** the licensed architect/engineer makes a visual exam of habitable and non-habitable areas of each building, including major structural components of the building. He must give a qualitative assessment of the structural conditions of each building. Ideally, this will be all we have to complete.

Phase 2 is a full assessment of all areas of structural distress to confirm that an area is structurally sound and safe. The inspector recommends a program for the complete evaluation and repair of the damaged portions of the building. Phase 2 may be as extensive as necessary to fully assess areas of structural distress. There are certain parameters that are still to be determined and may include roof, load-bearing walls, floors, foundations, lanais, plumbing, electrical systems, waterproofing, windows, and more.

Equally important, a structural integrity reserve study is to be performed. We are told by the state at this time to prepare for full reserves (100%) with no allowance to vote against them. This could change in May when the legislature meets again.

We now budget reserves at 3.5%. The 100% reserves law could change, as the cost may be prohibitive for many condo owners. We will know more in May 2023. Our Board of Directors is looking into all aspects of the new law including hiring an inspector, and will have some information for us by the November Board Meeting.

The Problem with Plastic Bags in the Recycle Bins.

Most of us like to put our plastic bottles, metal cans, and paper items in a plastic bag before tossing them into the recycling bin. No matter how harmless those plastic bags might seem, they're a big no-no. **So, what's the big deal?**

Material recovery facilities (the place where your recyclables are processed) can't handle plastic bags. They jam the processing equipment, which creates work stoppages. By work stoppages, it means the whole recycling facility has to shut down. Just because of plastic bags.

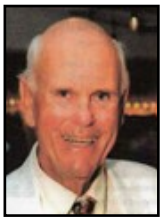
Some facilities don't even bother with the bags. When workers see them, they toss them in the garbage—even ones that contain perfectly good recyclables. Others schedule time for employees to clear bags from the machinery. This can take up to an hour every single day. Sometimes longer. Plus, it can be dangerous, since facility staff has to scale the equipment and use sharp carpet knives to cut the bags free.

Long Range Planning

October 10th, 2022 Report

Since our last meeting, we have received 28 See it Say it cards as well as 3 CEC official complaint forms and one legal notice.

Most of the See it Say it cards were investigated and resolved. However, 1 will need a follow-up and another is transferred to a CEC official complaint form with a fining recommendation to the BOD, which will be addressed in our New business portion of this meeting.

The 3 other CEC official complaint forms pertain to the same individual and we recommend that the BOD gets a legal opinion from our lawyers before continuing.

Other matters discussed: the possibility of electronic (Web) See it Say it cards. Adding the stop signs and limited hours for garbage and recycling disposals in our Rules and Regulations.
