Great Boards Focus on the Big Picture

It's the big picture that counts for great boards. A great board will stand back and observe if a policy is being carried out through each step of its operations, starting with management, continuing down through the vendors, and finally reaching the community at large.

Great Boards Hold Productive Meetings

Great boards hold efficient, productive meetings while still allowing unit owners to air opinions and board members to discuss, debate and act on various issues. When a great board member comes to a meeting, he or she will have read the agenda and board packet beforehand, that way they'll be ready to make decisions based on solid information. They know being prepared develops the community's trust in them as leaders and gives them the ability to make decisions on the community's behalf in a timely manner.



Great Boards Protect Against Liabilities

Great boards know that liabilities are a risk to LCG and to themselves, and always face that risk head-on by dealing with potential and evident liabilities quickly. Great boards understand, and never shy away from, risk management. They obtain information and direction from insurance, legal and management experts to guide them on the safest path.

Great Boards Remember Their Fiduciary Duty

A fiduciary is a person who occupies a position of special trust and confidence, and board members are fiduciaries to LCG's membership. To make decisions as fiduciaries, boards must base their decision on logic and reason, not on emotion or fear, giving the board and the community credibility and integrity for the long-term as they occupy that place of special trust and confidence.

The board is a deliberative body that makes decisions based on solid input. That input should include, but not be limited to, their own experience, facts, data, outside experts, standard of care of the industry and precedents set before them. Using this information, gathering tools, great boards make informed decisions that are best for the community, even when those decisions may be unpopular.

January 7, 2020

Julie Sauve asked Vilma Mally what happened to all the pictures and emails she received regarding complaints about the walkway painting. Vilma responded that she must have accidentally deleted them.

Diane O'Shea spoke about her wish to end the division at LCG and come together as a community.

Jack Pillsbury and **Rosemary Pacheco** asked why Seamus Brennan was denied a recount of votes (a recount was done the next day). Cost for attorney's fees are not yet finalized.

Jeannie Melchoiri asked for an explanation of events in regards to the 2019 election and arbitration. The arbitrator ruled in favor of Seamus.

Mary Menis claimed that the letter that was sent out by Aless Hall "accusing seven people of harassing, bullying and intimidating the residents of LCG to vote for their candidates" was false. She also claimed that a second letter contained false information about the arbitration.

Voting Code of Behavior



With the LCG elections taking place this month, this is a good time to remind everyone of the State law regarding election procedures. In order to have a fair and honest election, please review the information below.

The Florida Statutes (F.S.) provides specific processes and procedures relating to condominium association Board member elections. These rules have been established to ensure fair elections and to provide all unit owners interested in running for a seat on the Board the opportunity to do so.

Under the new Condo Law, if there is a forged ballot or voting certificate in a condo election, then it is a crime punishable under F.S. 831.01, the state criminal law against forgery, which states:

"Whoever falsely makes, alters, forges or counterfeits a public record, or a certificate, return or attestation of any clerk or register of a court, public register, notary public, town clerk or any public officer, in relation to a matter wherein such certificate, return or attestation may be received as a legal proof; or a charter, deed, will, testament, bond, or writing obligatory, letter of attorney, policy of insurance, bill of lading, bill of exchange or promissory note, or an order, acquittance, or discharge for money or other property, or an acceptance of a bill of exchange or promissory note for the payment of money, or any receipt for money, goods or other property, or any passage ticket, pass or other evidence of transportation issued by a common carrier, with intent to injure or defraud any person, shall be guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084."

718.112 Required Provisions—

A unit owner may not permit any other person to vote his or her ballot, and any ballots improperly cast are invalid. A unit owner who violates this provision may be fined by the association in accordance with s.718.303.

If you observe any violation of these rules, you are asked to contact the office immediately. Your identity will not be revealed to the offending party. Elections are taken seriously.

We have 855 units here at Lake Clarke Gardens, yet only about half of the owners vote.

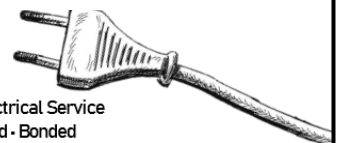
Voter apathy can hurt you: Do not be a part of the problem; be a part of the solution. Vote.

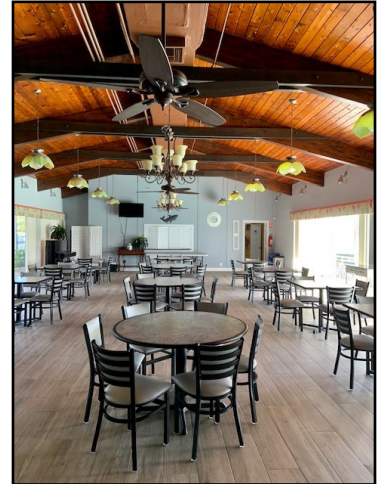
It Takes a Village...

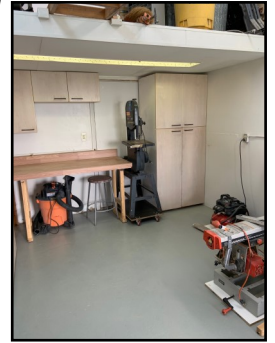

Speaking of Woodchuck, our own **Chuck Boudreau** has chucked a lot of wood and other debris from the Wood Shop. Five cartloads, to be exact. The renovation of the LCG Wood Shop is complete, including a fresh coat of paint on the walls, grinding of the floor and a coating of epoxy, along with the installation of new cabinets and work bench has made the shop very presentable, and an area that owners can be proud of. We encourage everyone to stop by to have a peek and thank Chuck on Wednesday, February 5th between 1:00 PM and 3:00 PM.



Understandably, there are Rules that go along with the use of the shop that need to be followed. They will be posted in the shop and we ask that all users become familiar with and comply with them. The **TEMPORARY RULES** are listed below:

USERS OF THE WOOD SHOP MUST COMPLY WITH THE FOLLOWING:

- The use of the Wood Shop (Shop) is for LCG residents and employees only. Any business or commercial use of this area and/or tools is prohibited.
- The key to the wood shop is available to be signed out in the office.
- Security of the Shop and the key are the responsibility of the person signing out the key. The key shall not be transferred to another person. It shall be returned to the office immediately after your work project is complete and in no event later than 4:00 PM on the date of sign out. If the office is closed the key shall be placed in the "Drop Box".
- Shop hours are 8:00 AM thru 4:00 PM, Monday thru Friday. No work before 8am or after 4pm.
- Generally, tools are not to be removed from the Shop. Occasionally it is permissible to borrow portable tools for short duration, (a few hours), as long as the tool is signed out on a sign out sheet, maintained in the Shop, and returned immediately after use.
- All persons using power tools within the Shop must be familiar with the proper operation and safety precautions associated with these tools.
- Users of the Shop shall ensure that they clean up after themselves after each use prior to leaving the Shop.
- The Shop shall not be used as a storage area for personally owned materials or tools.
- No alterations are to be made to the Shop.
- Caution is to be taken when using toxic or flammable materials such as paint, stain, glue, stripping or cleaning materials. This is a small confined area and any materials labeled "to be used in well ventilated area" shall not be used in the Shop.
